1. The Government of Nepal (GoN) has allocated funds towards the cost of construction of National Mushroom resource center (NMRC) at Khopasi, Kavrepalanchowk and intends to apply part of the funds to cover eligible payments under the Construction of production and conservation block of National Mushroom resource center (NMRC) at Khopasi, Kavrepalanchowk (ConNMRC/NCB/Works/01/082/083). Bidding is open to all eligible as per Section V of bidding document.
2. **Sericulture Development Center, Khopasi, Kavrepalanchowk** invites electronic bids from eligible bidders for the **Construction of Production and Conservation Block of National Mushroom Resource Center at Khopasi, Kavrepalanchowk** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 11,35,000,00.00/-**
 - Minimum Work experience of similar size and nature: one (1) contracts of **at least One (1) Contract within the last ten (10) years, with a value of at least NRs 4,50,00,000.00 that have been successfully or are substantially completed.**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

5. Bidder need to submit their bid electronically by download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (PDF format) of the Bank deposit voucher of a non-refundable fee of NRs 5,000.00 (Five Thousand only) shall be uploaded by the bidder at the time of electronic submission of the bid.

8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 hrs on 2082/06/22 at the office of Sericulture Development Center, Khopasi, Kavrepalanchowk**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a scanned copy of the bid security in pdf format amounting to a minimum of **NRs. 1900,000/-**, which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
